### Student Entitlement

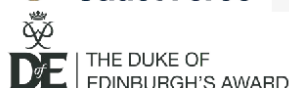
All students in **Years 8 to 13** are entitled to:

## Minimum Provider Encounters (from January 2023)

Key Phase	Year Groups	Number of Encounters	Attendance Requirement
Phase 1	Year 8 or 9	2	Mandatory for students
Phase 2	Year 10 or 11	2	Mandatory for students
Phase 3	Year 12 or 13	2	Optional for students

Each encounter must last **at least 30 minutes** and take place during the **academy day 9am – 3.25pm**.

## What Providers Can Expect

During an encounter, providers will have the opportunity to:

- Share information about their **courses and qualifications**.
- Explain **career pathways** linked to their offer.
- Provide a **realistic insight** into their learning environment.
- Engage with **all students**, including our most able, vulnerable and those with additional learning needs.

## Working in Partnership

We welcome requests from approved providers and proactively invite them to participate in:

- Extended Assemblies and curriculum-linked sessions
- Enrichment activities and Post 16/18 options events
- Live online sessions (subject to tech checks)

## Requesting Access

To request access, providers should ideally contact the **Careers Leader** at least **6 weeks in advance**, (although some short notice requests may be considered) including:

- Proposed format, date, and duration
- Number of visiting staff
- Any support or equipment needed

Requests will be considered based on:

- Timetabling and exam schedules
- Staff and space availability
- Safeguarding considerations

If approved, providers will be offered:

- A suitable space (e.g., Main Hall)
- Audio Visual equipment and stationery
- Support from at least one member of staff

## Safeguarding

All visitors must comply with our safeguarding procedures. A risk assessment will be completed by the school prior to any visit.

As well as the Careers Leader, our careers provision is regularly reviewed by:

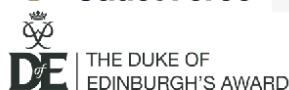
- The Senior Leadership Team
